(Outline)

Article 1: As per Article 21 of the Kumamoto University Rules and Regulations for the International House (enacted on April 1, 2004, and hereinafter called "Rules and Regulations"), these University Regulations stipulate matters regarding the use of Kumamoto University International House (hereinafter called "I-House").

(Application for Residence)

- Article 2: Those who wish to reside in I-House in accordance with Clause 1 of Article 6 of Rules and Regulations must submit an Application for Applying to Rent a Room at the Kumamoto University International House (Form 1) to the Director of the Headquarters for Admissions and Education (hereinafter called "Director") via the dean of the relevant faculty or the academic advisor.
- 2. Those who have been admitted to I-House must move in by the date specified in the Notification of Acceptance of Residency (Form 2); provided, however, that this shall not apply to cases where there is a special reason to extend the time period, as the Director deems necessary.

(Procedures for Moving In)

Article 3: Those who have been admitted as residents must submit a Notice of Occupancy (Form 3) and a Pledge (Form 4) to the Director.

(Procedures for Moving Out)

Article 4: Those who plan to vacate their rooms must submit a Notice of Departure (Form 5) to the Director; provided, however, that this shall not apply to cases when the residence permission is revoked as per Clause 1 of Article 9 of Rules and Regulations.

(Procedures for Use of Common Facilities)

- Article 5: Those who seek permission to use the common facilities in accordance with Article 15 of Rules and Regulations must submit an Application for Room Reservation of the International House (Form 6) to the Director in advance.
- 2. When the application is accepted, a Permission for Use of Common Facilities (Form 7) will be issued to the applicant.

(Utilities)

- Article 6: Utilities including heating, lighting, and water and other necessary expenses provided in Clause 3 of Article 8 of the Rules and Regulations are as follows:
- (1) For electricity, water, and gas, Residence A and B are charged according to the gas meter of each room (gas is charged only to the researcher room residents). Residence C and D are charged as stated separately.
- (2) Expenses for cleaning the room and exchanging keys when the occupant has moved out
- (3) Expenses for managing the I-House as the Director deems necessary
- 2. Residents must pay utilities and other necessary expenses as described above to the person whom the Director specifies by a prescribed date.

(Compliance)

Article 7: Residents must comply with the following conditions as well as the items provided in Rules and Regulations.

(1) Do not move from the assigned room to another room without permission.

(2) Do not lend the room to others and do not use the room for any purpose other than living.

(3) Do not move the facilities in the room and do not remove the furnishings from the room.

(4) Follow the instructions of the separately provided "Occupant Regulations" and the University staff. Supplementary Provisions
